General Information

Date: Saturday, July 17, 2010, 10:00 AM until 4:00 PM, RAIN OR SHINE

ENTRY FEE: \$20.00 PER SPACE (*Limit two spaces per registration*)

Spaces will be assigned per the date the application is returned. Your space number will be on the bottom of your confirmation letter. There will be **NO REFUNDS** – as spaces are reserved. There will be no leasing or selling of your space.

DEADLINE FOR ENTRIES IS MAY 31ST OR UNTIL FULL!
(*All entries must be postmarked*)

RULES:

- **A total of two exhibitors per booth.** (No children under 12 years of age or pets.) Exhibitor agrees to remain open and not dismantle display before 4:00 pm. All vendors must abide by the vendor vehicle parking rules on the day of the show.
- **Exhibitor must supply two photos of their craft, one must be a display set-up.** Photos will not be returned
- **Exhibitor must supply a self-addressed, stamped envelope** for the show or no confirmation will be sent.
- **No food, drinks or edible baked good “crafts” will be permitted.** A variety of food concessions are available on the Tudor House grounds.

SET-UP:

You **must** check in at the Registration Center located in the Tudor House. Please sign in and pick up your Registration Package at the front door.

- ❑ Friday night, **July 16th** will be from 4:00 pm to 8:00 pm. There will not be any overnight security. Overnight camping is prohibited. You may want to set up your canopies or booths and finish the set up in the morning.
- ❑ **Saturday, July 17th will start at 7:00 am to 9:30 am**

Exhibitors must bring their own tables, chairs, tents, canopies, etc., which are the responsibility of the exhibitors. It is recommended that you include some type of covering to protect your booth contents and workers from the weather. **Please keep in mind** this festival is held outdoors in a lake-site park with areas of rolling, uneven contours, trees and sloping

walkways. All stakes used to hold down or secure a tent, booth or canopy must have protective corners. Stakes or ropes are not to be located in the aisles or walkways.

Unloading/Parking: Immediately **after** unloading and **before** set-up is started, all vehicles must be moved to the designated parking area as unloading space is very limited.

Assigned number must be displayed in the window of your vehicle and in your booth.

All vehicles MUST be moved from the unloading area BY 9:30 AM on July 17, 2010.

Exhibit Hours: Hours are the show hours, 10:00 am to 4:00 pm. All exhibitors must keep their tents, canopies, etc. intact. Permission for an exhibitor to leave early will be granted only in a medical or emergency situation. Any exhibitor leaving without permission from the Arts & Craft Show will not be accepted for any future shows.

A check must accompany show application. Any returned checks by the bank will be subject to a \$25.00 charge for insufficient funds.
